MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES OF

THE CULTURAL ARTS ACADEMY CHARTER SCHOOL AT SPRING CREEK

A Meeting of the Board of Trustees of the Cultural Arts Academy Charter School at Spring Creek was held at 1900 Linden Boulevard, Brooklyn, NY on September 21, 2011 at 6:00 PM.

The meeting was called to order. A quorum was present.

A discussion was held regarding the Annual Site Visit Report conducted by the New York City Department of Education Charter Schools Office prepared by Sonia Park, Senior Director of the NYC DOE CSO and Sylvia Rabiner, Consultant. The overall assessment was very positive.

A copy of the Board of Trustees Monthly Meeting Protocol and Procedures was distributed to the Members of the Board.

The Principal, LAURIE MIDGETTE and DEAN T.S. HOARD, Dean of Content and Curriculum provided an update on school developments including, but not limited to:

- 1. The introduction of a new music program Violin instruction for second graders in conjunction with the Noel Pointer Foundation.
 - 2. The introduction of two new "colleges", Princeton and Cornell.
- 3. The addition of new curriculum in math to include differentiated math; a new technology lab; new drama and dance programs and a health education program.

A Strategic Plan has been prepared to:

- 1. Add arts in the after school program;
- 2. (a) Extend class time by providing an optional breakfast at 7:00AM and a starting time for classes of 7:30 AM; and
- (b) By having Fifty (50) minute periods rather than Forty Five (45) minutes periods.
- 3. Establish School Staff Committees, i.e., a media team, a cultural arts committee, a special needs development team and a health awareness committee;
 - 4. Establishing sports teams.

The Math and Science curriculums are being changed. The Saxon Math Curriculum is being replaced by the Envision Math program which is more rigorous, employs virtual learning, daily enrichment and has a writing component. The Science program is also being upgraded to a more rigorous program, the Foss science program.

After School programs are being developed and were expanded to provide chess, a choir, percussion training, dance and drama and intramural martial arts.

The new Parent Teacher Association Members are expected to attend our next Board Meeting on October 19, 2011. The role of the PTA will be to support the Administration of the Charter School and the mission and vision of the school and to provide ongoing fundraising events.

The accountant for the school, STUART SABAL presented the financial statement for the Charter School as of June 30, 2011 as well as the profit and Loss Budget Overview for the period of July, 2011 through June, 2012.

Upon Motion of HENRY J. CLOUDEN III the financial statement (subject to audit) and the Profit and Loss Budget Overview for 2011 and 2012 was unanimously approved, and seconded by SUSAN FOX,

A discussion was held regarding the requirement that the Board of Trustees meet a minimum of twelve (12) times per year.

Upon Motion of HENRY J. CLOUDEN III to amend paragraph 12 of the By-Laws to provide that the Board of Trustees meet a minimum of twelve (12) times per year and seconded by SHIRLEY GLASGOW, the Motion was unanimously approved.

A discussion was held regarding the Discipline and Safety Policy.

Upon Motion of HENRY J. CLOUDEN III to approve the Discipline and Safety Policy for 2011 intact for 2012 and seconded by SHIRLEY GLASGOW, the said policy was approved unanimously.

There being no further business before the Board of Trustees, the meeting was adjourned.
