Important Notes Regarding 2023-2024 In-Person Board Meeting Attendance Requirements In adherence with the most recent health guidance, the following requirements are in place to attend a Board of Trustees Meeting, until further notice.

• **Social Distancing** - The meeting will take place in a room that allows for social distancing between attendees.

- **Health** Anyone who is feeling ill may not enter the building. Anyone who displays signs or symptoms of COVID-19 such as fever, cough, shortness of breath, chills, muscle pain, headaches, sore throat, and/or a new loss of taste or smell may not enter the building.
- **COVID-19 Tracing** A form will be filled out and kept on file for all people entering the building for this event.

**Select Board Meetings** may be conducted virtually via Mayor Adams,' executive orders that may extend NYC's COVID-19 State of Emergency for certain time periods. Note that New York State has already ended its state of emergency due to COVID-19. These executive orders will allow for entitles in New York City subject to OML, including all charter schools, to continue to hold meetings virtually (for charters this will impact board and board committee meetings). **We will keep you updated if there is a further extension to NYC's State of Emergency.**
