CURRICULUM NIGHT

During the week of September 12th, Cultural Arts Academy Charter School held two virtual curriculum night events for our K-5 families via the use of the Zoom and Google Meets digital platforms. Grades K-2 Curriculum Night took place on Tuesday, September 13th. Grades 3-5 Curriculum Night took place on Thursday, September 15th. It is important to note that our curriculum night events provide families with the opportunity to get better acquainted with instructional staff members while also receiving a better understanding of the curriculum being implemented for the 2022-2023 school year.

Each night commenced with a welcome address presented by Dean Mc Laurin and Dean Odigie (Co-Directors of Curriculum and Instruction). This welcome address was done on the behalf of Dr. Laurie Midgette who is the founding principal of CAACS. Once the families were welcomed and were provided with an overview of the night's agenda, they received informative presentations from Dean Morales (Leader in Me Coordinator) and Dean Hong (International Baccalaureate Coordinator).

Next, families heard from our instructional specialists who provided a general idea of the curriculum that will be used this school year. The specialists also unpacked the skills/standards that scholars would be exposed to during this school year and identified supportive tips to help foster student achievement. It is important to note that Dean

George presented for the K-2 Curriculum Night event as she is the instructional specialist for the K-2 cohort. Consequently, Dean Alequin presented for the 3-5 Curriculum Night as she is the instructional specialist for the 3-5 cohort.

Finally, each night ended with families leaving the general Zoom meeting to attend individual class meetings held through the use of Google Meets link. These final moments of the night afforded classroom professors with the opportunity to speak with families about our grading and homework policies. Professors also spoke on classroom procedures. It is also important to note that parents were given the opportunity to get to know their child's professor and to have their questions answered.

Below you will find a breakdown regarding parent attendance for our 1st Curriculum (Grades K-2)

- Kindergarten (Harvard University) 11 families
- 1st Grade (Fisk University) 3 families
- 1st Grade (Hampton University) 14 families
- 2nd Grade (Georgetown University) 6 families

This gives us a total of 34 families attending our first virtual curriculum night, or 43% (34/79). In closing, we really enjoyed meeting with the parents and providing them a better understanding regarding our Expectations.

Below you will find a breakdown regarding parent attendance for our 2nd Curriculum (Grades 3-5)

- 3rd Grade (Notre Dame University) 9 families
- 3rd Grade (Grambling University) 6 families
- 4th Grade (Howard University & Cornell University) 8 families
- 5th Grade (Brooklyn College) 2 families
- 5th Grade (Princeton University) 7 families

This gives us a total of 32 families attending our first 3-5 virtual curriculum night, or 27% (32/120)
