### FINANCIAL REPORT

The financial statements of Cultural Arts Academy Charter School for the eleven months ended May 31, 2013 prepared by Stuart Sabal were presented. These statements were discussed in detail and there is sufficient cash to fund monthly operations through the end of the school.

#### **STAFFING**

There was a powerpoint presentation by DOCC Applicant, Patrick McKinney on

- 2 different definitions of leadership
- 2 distinct forces that dictate how to act with an organization
- 5 traits of Leaders
- Share your personal definition of Leadership
- List and describe what Leadership Qualities will be
- Describe your leadership style

We further discussed the staffing needs, hiring of additional teachers and a Director of Accountability & Compliance, and an additional safety officer and custodial staff.

The review of the Data Dashboard June 2013-2013 is in draft form and the revision of the CAACA Website will revised over the summer. The renewal process for CAACS will begin this August.

The overall scores for the NYS ELA and Math assessments for the  $3^{\rm rd}$  grade were 86.2% passing for ELA and 97.9% passing for Math. The attendance for the first half of May 2013 was 96.7.

The Parents Association Carnival event was a great success. They plan to have this event annually because of such a good response.

CAACS has partnerships with Noel Pointer Foundation (Violin Program), Arts Horizon (Art and Music classes – Piano and Recorder), Heart song (Art and Musical therapy for SPED students), Broadway Jr.(part of a Jazz Program at Lincoln Center).

The Charter Accountability goals, the school calendar, Common Core Learning Standards Implementation Plan for 2013-2013 and renovation were also reviewed.

A motion was made by Chrysetta Patterson to adjourn and seconded by Shirley Glasgow. Meeting adjourned at 9:07pm.
